

Houston Homebuyers Seek Value in More Affordable Communities



HAR released the Q2 2024 report on the **Hottest Communities in the Houston Area** this week.

Here is a look at some key takeaways:

- Porter/New Caney West had the greatest percentage increase of home purchases in the second quarter of 2024, with transactions increasing 140.5 percent year-over-year. The average home price there was \$290,456.
- Newly built homes accounted for the majority of sales in the top two communities in the report.
- Nine of the top ten communities in the report had average home prices below the Houston area's average of \$432,090, according to HAR's June 2024 Housing Market Update.
