

# **DATA SERVICES AGREEMENT (2-WAY AND 3-WAY THIRD PARTY):**

## Option 1:

<u>Data Services Fee</u>. BROKER shall pay to HRIS, or cause it to be paid, the fees and applicable sales tax as selected by BROKER below:

<u>Active Listings</u> - Access to MLS Data with status of Active, Option Pending, Pending Continuing to Show, and Pending. HRIS' MLS Rules permit the display of "Active" listing information subject to "Internet Data Exchange" (IDX) guidelines.
